If from published or unpublished records, applicant must submit title pages and pertinent pages, underscored and marked in red. Proof of parent's marriage date is required. Spouse in every instance means legal and lawful spouse. If you are using another societies application please fill out each generation and under proof state which society, (i.e. NSDAR, Colonial Dames XVII C, etc). You must attach a copy of the completed application from that society and proof it was accepted for membership.

If legatees are from a marriage other than the present one, line six of generation one must be completed.

Any previously approved paper used as a reference for any generation must be one which conforms to the Bylaws changes and to the Instructions and Directives of the NMDA Registrar.

If joining using the application of another family member who is a member of the NMDA (parent, grandparent, cousin, etc) fill in full application and see the NMDA instruction form for further instruction.

Where known fill in city, county, and state or colony for all place names (i.e. Yorktown, York, VA). Type all dates using the format Day, Month, Year (14 Jan 1952).
